DISCLOSEABLE TRANSACTIONS IN RELATION TO THE FINANCE LEASE AGREEMENTS AND CONTINUED SUSPENSION OF TRADING

FINANCE LEASE AGREEMENT I

Reference is made to the Announcement. As disclosed in the Announcement, the Purchaser entered into the Finance Lease Agreement I with Yuanpeng on 28 December 2023. Finance Lease Agreement I has been settled on 25 December 2025.

FINANCE LEASE AGREEMENT WITH YUANPENG

On 7 January 2026 (after market close), the Purchaser entered into a sale-leaseback transaction with Yuanpeng under the Finance Lease Agreement. Pursuant to the Finance Lease Agreement, the Purchaser has agreed to purchase from Yuanpeng the Leaseback Assets at the Consideration of RMB17,500,000 (equivalent to approximately HK\$19,409,775), and lease to Yuanpeng the Leaseback Assets for a term of 36 months in return for the Lease Payments.

IMPLICATIONS UNDER THE GEM LISTING RULES

As one or more of the applicable percentage ratios (as defined in the GEM Listing Rules) in respect of the transactions contemplated under the Finance Lease Agreements on a standalone basis and on an aggregate basis exceed 5% but are less than 25%, such transactions constitute discloseable transactions of the Company under Chapter 19 of the GEM Listing Rules and is subject to the notification and announcement requirements under Chapter 19 of the GEM Listing Rules.

INTRODUCTION

Reference is made to the Announcement. As disclosed in the Announcement, the Purchaser entered into the Finance Lease Agreement I with Yuanpeng on 28 December 2023. Finance Lease Agreement I has been settled on 25 December 2025.

On 7 January 2026 (after market close), the Purchaser entered into a sale-leaseback transaction with Yuanpeng under the Finance Lease Agreement. Pursuant to the Finance Lease Agreement, the Purchaser has agreed to purchase from Yuanpeng the Leaseback Assets at the Consideration of RMB17,500,000 (equivalent to approximately HK\$19,409,775), and lease to Yuanpeng the Leaseback Assets for a term of 36 months in return for the Lease Payments.

FINANCE LEASE AGREEMENT

The principal terms and conditions of the Finance Lease Agreement are summarised as follows:

Date: 7 January 2026

Parties: (1) The Purchaser (the lessor)

(2) Yuanpeng (the lessee)

Assets acquired: The Leaseback Assets are four fully automatic rotor spinning machines, and one set of blow-room/carding line.

Consideration: The Consideration for the purchase of the Leaseback Assets is RMB17,500,000 (equivalent to approximately HK\$19,409,775).

The Consideration payable by the Purchaser was based on the original purchase prices payable by Yuanpeng for the purchase of the Leaseback Assets as evidenced by the invoices issued by the relevant vendors and the valuation report issued by qualified evaluation institution. In determining the amount of the Consideration, the Purchaser has made reference to the original purchase prices of the Leaseback Assets, and determined the amount through arm's length negotiation with Yuanpeng.

Payment of
Consideration: Subject to the fulfilment of certain conditions, including, among others, the receipt by the Purchaser from Yuanpeng of (i) a complete set of documents or documentary proof relating to the ownership of the equipment and any other documents requested by the Purchaser; and (ii) Yuanpeng's declaration that it has legal ownership over the Leaseback Assets and that no encumbrance has been created in respect thereof, the Purchaser shall pay to Yuanpeng the Consideration within 7 business days after the fulfilment of the aforesaid conditions.

The Consideration will be financed by the Group's internal resources and bank borrowings.

Ownership of the Leaseback Assets:	The Purchaser will be entitled to the Leaseback Assets upon the signing of the Finance Lease Agreement.
Lease term:	The Leaseback Assets shall be leased by the Purchaser to Yuanpeng for a term of 36 months commencing from 8 January 2026.
Lease Payments:	<p>The aggregate Lease Payments for the entire three-year lease term is RMB20,400,000 (equivalent to approximately HK\$22,626,252).</p> <p>The Lease Payments shall be payable by Yuanpeng by 12 quarterly instalments commencing from 8 April 2026. The first to the eighth quarterly instalments shall be RMB350,000 (equivalent to approximately HK\$388,196), the ninth to the twelfth quarterly instalments shall be RMB4,400,000 (equivalent to approximately HK\$4,880,172).</p> <p>The aggregate Lease Payments for the entire three-year lease term was based on the Consideration plus the total amount of interest agreed to be charged by the Purchaser to Yuanpeng for the entire lease term.</p> <p>The effective annual interest rate for the sale-leaseback transaction under the Finance Lease Agreement is 6.6% per annum. The interest rate was determined by the Purchaser and Yuanpeng through arm's length negotiation, and in determining the interest rate, the Purchaser has taken into account the prevailing bank lending rate, creditability of Yuanpeng with reference to its credit track record, as well as the interest rate payable by companies comparable to Yuanpeng.</p>
Security deposit:	A security deposit of RMB500,000 (equivalent to approximately HK\$554,565) shall be payable by Yuanpeng to secure the performance of its obligations under the Finance Lease Agreement. In addition, the Purchaser may (i) apply the security deposit to settle the final outstanding amount of the Lease Payments; or (ii) pay it back to Yuanpeng without interest after Yuanpeng has fully discharged its payment obligation under the Finance Lease Agreement; or (iii) apply the security deposit to offset the amount of consideration for the early buyback of the Leaseback Assets by Yuanpeng provided that Yuanpeng has fulfilled its obligations under the Finance Lease Agreement and there is no default on the part of Yuanpeng (or has there been any default, such default has been cured and the liquidated damages have been duly paid).

- Liquidated damages: If Yuanpeng fails to pay any amount of the Lease Payments due or any other amount payable under the Finance Lease Agreement, Yuanpeng shall pay liquidated damages from the payment due date, which is equivalent to the product of (i) the amount of late payment; (ii) a daily default rate of 0.05%; and (iii) the number of days from the payment due date to the full settlement date.
- Retention consideration: Subject to the fulfilment of all of Yuanpeng's obligations under the Finance Lease Agreement and the payment of the last instalment for the Lease Payments, Yuanpeng may repurchase the Leaseback Assets from the Purchaser upon the retention payment at the consideration of RMB100 (equivalent to approximately HK\$111).
- Early buyback by Yuanpeng: The Purchaser has agreed that Yuanpeng may repurchase the Leaseback Assets before the date on which the final instalment shall be payable, provided that (i) there is no default on the part of Yuanpeng (or has there been any default, such default has been cured and the liquidated damages have been duly paid); (ii) Yuanpeng gives the Purchaser a 30-day prior written notice of the proposed early buyback; and (iii) the Purchaser has consented in writing to the proposed buyback by Yuanpeng.
- The Purchaser has agreed to transfer the ownership of the Leaseback Assets to Yuanpeng, provided that Yuanpeng has paid to the Purchaser in full the following sums as of the date of purchase to be agreed among the parties: (i) all the payments of liquidated damages and the lease payment for the month in which the early buyback takes place; (ii) the outstanding principal to be paid; (iii) the compensation payment representing 1% of the outstanding principal; and (iv) the retention consideration of RMB100 (equivalent to approximately HK\$111).
- Events of default: The Purchaser may take one or more of the following measures: (i) terminate the Finance Lease Agreement, take possession and dispose of the Leaseback Assets and claim against Yuanpeng for damages; (ii) declare that the outstanding Lease Payments, other amounts payable by Yuanpeng and the liquidated damages shall be immediately payable by Yuanpeng; (iii) claim against Yuanpeng any fee arising as a result of enforcing or defending the Purchaser's rights under the Finance Lease Agreement; and (iv) seek other relief as permitted by the law, upon the occurrence of certain triggering events, including, among others, failure to pay on time any instalment of the Lease Payments or any other amount payable by Yuanpeng in full or the failure of Yuanpeng to perform any other duties and obligations under the Finance Lease Agreement and such failure has not been cured within 7 days after the written notification from the Purchaser to Yuanpeng.

REASONS FOR AND BENEFITS OF THE TRANSACTIONS

The Purchaser is primarily engaged in finance leasing business in the PRC. It is expected that the Finance Lease Agreements will enable the Group to earn an aggregate income of approximately RMB5,423,200 (equivalent to approximately HK\$6,015,034) over their respective lease term.

Given that the Finance Lease Agreements were entered into in the ordinary and usual course of business of the Purchaser and were agreed between the Purchaser and the lessee on normal commercial terms, the Directors are of the view that the terms of Finance Lease Agreements are fair and reasonable and are in the interests of the Group and the Shareholders as a whole.

INFORMATION ON THE CREDIT ASSESSMENT IN RESPECT OF THE FINANCE LEASE AGREEMENTS

The entering into of the Finance Lease Agreements were determined on the basis of the Company's credit assessment made on, inter alia, the financial strength and the background of the lessee. The Company has prepared the due diligence report to evaluate the creditworthiness of lessee, which provides an important reference for its credit risk management. In preparing such report, the Company has analysed the balance sheet, profit and loss statement and cash flow statement of Yuanpeng, and the biographical information of its ultimate beneficial owner. Yuanpeng has a good reputation, proven track records and a long working relationship with the Group. Based on the credit assessment, the Company considers that the credit risk relating to entering into the Finance Lease Agreements is relatively low.

The Board (including the independent non-executive Directors) is of the view that the Finance Lease Agreements: (i) are entered into in the ordinary and usual course of business of the Group; (ii) are on normal commercial terms; and (iii) are on terms that are fair and reasonable and in the interests of the Company and its Shareholders as a whole; and that the consideration under each of the Finance Lease Agreements is fair and reasonable and in the interests of the Company and its Shareholders as a whole.

INFORMATION ABOUT THE GROUP

The Group is primarily engaged in (i) the provision of financial services including equipment-based financing solutions, and financial information service to customers, and (ii) packaging and paper products trading.

INFORMATION ABOUT THE PURCHASER

The Purchaser is a company established in the PRC and principally engaged in finance leasing business in the PRC.

INFORMATION ABOUT YUANPENG

Yuanpeng, the lessee under the Finance Lease Agreements, is a company established in the PRC with limited liability, which is principally engaged in apparel manufacturing and trading of apparel and apparel accessories. Yuanpeng is ultimately wholly owned by Cai Xiaozhu (蔡曉築).

To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, Yuanpeng and its ultimate beneficial owner are Independent Third Parties and are not connected with any of the Company's connected persons.

IMPLICATIONS UNDER THE GEM LISTING RULES

As one or more of the applicable percentage ratios (as defined in the GEM Listing Rules) in respect of the transactions contemplated under the Finance Lease Agreements on a standalone basis and on an aggregate basis exceed 5% but are less than 25%, such transactions constitute discloseable transactions of the Company under Chapter 19 of the GEM Listing Rules and is subject to the notification and announcement requirements under Chapter 19 of the GEM Listing Rules.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 9 June 2025 and will remain suspended until the trading of the Shares is allowed to resume by the Stock Exchange after re-compliance with Rule 17.26 of the GEM Listing Rules, fulfilment of the resumption guidance and full compliance with the GEM Listing Rules to the satisfaction of the Stock Exchange.

Further announcement(s) will be made by the Company to update the Shareholders on the progress of the resumption as and when appropriate and in accordance with the requirements of the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the Shares.
